prosecution could lie or shall entitle the LESSOR to determine the tenancy and lay claim for damages, if any, arising out the same.

20. The LESSEE shall hand over possession of the DEMISED PREMISES to the LESSORS at the expiry of the LEASE PERIOD or sooner on the termination of the lease by either party, in the same condition in which the DEMISED PREMISES was handed over by the LESSORS to LESSEE. 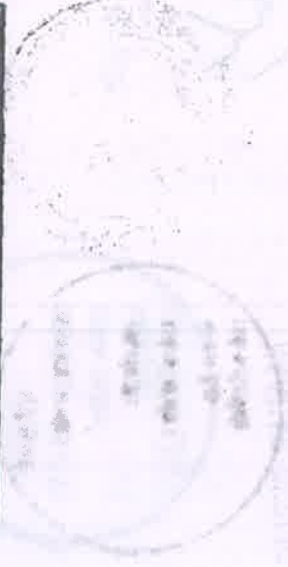

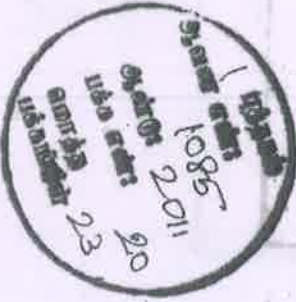

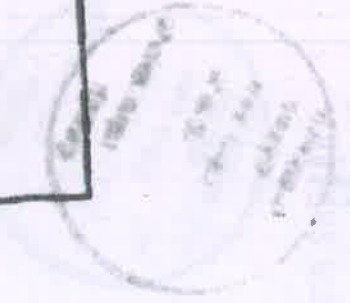
